- To provide support and information to DPs for income restoration
- Assist the DPs in redressing their grievances (through the GRC set up by the subproject)
- Assist the DPs in relocation and rehabilitation, including counseling, and coordination with local authorities.









- Educating the DPs on their rights to entitlements and obligations.
- To assist the ADB-Project Implementation Unit with social responsibilities of the subproject, such as compliance with labour laws, prohibition of child labour, and gender issues.
- To conduct awareness program for HIV/AIDs, Human Trafficking.
- To collect data and submit progress reports on a monthly and quarterly basis for CGPWD to monitor the progress of RP implementation.

•Explain to the DPs the provisions of the policy and the entitlements under the RP.

•Find the possible option of the DPs for their livelihood systems if affected by this project.

•Contact Sarpanch, Panch, Kotwar, Janpad Panchayat Members and local authorities to be solve problems together.

•Provide vocational training to eligible DPs for skills up grading their livelihood.

•Create Understanding Between Government and Displaced Persons.
