To assist the ADB-Project Implementation Unit with social responsibilities of the subproject, such as compliance with labour laws, prohibition of child labour, and gender issues.

To conduct awareness program for HIV/AIDs, Human Trafficking.

To collect data and submit progress reports on a monthly and quarterly basis for CGPWD to monitor the progress of RP implementation.

- Forward complain to GRC.
- Road Safety Campaign, HIV awareness, enforcing labour standards for construction work.
- Follow the instruction of supervision consultant.
- Prepare monthly & Quarterly Progress report to PIU
