# WHAT WE IMPLEMENTED THIS YEAR..

- Due to **Water, Sewerage and Carpet Area** problem in our previous OSH Building, we shifted our OSH to **Tiwari Farm House, Dadar Khurd, Manikpur Road, Korba (Chhattisgarh)**.
- For Summer we install the **Air Water cooler** and provided **some other Products** to the children.
- We have registered each child at [www.trackthemissingchild.gov.in](http://www.trackthemissingchild.gov.in) to maintain the basic details of children.
- We have hanged the **Hoardings** at our Contact Points.
- Established the **Landmarks** on the various Paths of our OSH so that reaching OSH became easy.



# CONT...

- This year onwards we have covered **Korba District**. We are approaching Children from different places to our OSH.
- We have distributed the children into 3 groups and made the committee of Children according to their ages.  
Three children committee are as follows:
  - (1) **6-10 years**
  - (2) **11-15 years**
  - (3) **16 -18 years**

कोरवा. पांच साल पहले एकाएक घर से लापता हुए अपने मासूम बच्चे के मिलने की उम्मीद छोड़ चुके परिवार का उस वक़्त खुशी का ठिकाना नहीं रहा, जब बच्चे के इंतज़ार में पथराई आंखों से अपने लापता हुए बच्चे का सकुशल अपने पास देखा। उत्तर प्रदेश से भटककर कोरवा जिले के एक दूरस्थ गांव में रह रहे बालक को उनके परिजनों से मिलाया गया। उत्तर प्रदेश राज्य के कौशाम्बी निवासी रावेंद्र उर्फ़ रमेम पांच साल पहले ट्रेन में बैठकर बिलासपुर छत्तीसगढ़ आ पहुंचा। कुछ दिनों तक रतनपुर क्षेत्र में भटकने के पश्चात कोरवा जिले के पौड़ी उपरोड़ा विकासखंड अनन्तगत ग्राम कोनकोना पहुंच गया। कोनकोना में काफी समय तक रहने के दौरान ठकुर बालक से स्थानीय निवासी अवधेश प्रताप सिंह से मुलाकात हुई। बातचीत के दौरान बालक म्वेन्द्र ने अपने पिता का नाम सुनाड निवासी ग्राम
